IRS Audit Update

The IRS has steadily been increasing the number of 403(b) and 457(b) Plan audits they perform on public education employer plans as well as on non-profit plans such as those for churches and hospitals. TSA Consulting Group (TSACG) provides audit assistance to all clients as a standard deliverable. If you receive notice from an IRS auditor that your plan(s) is under audit, contact your Program Consultant at TSACG immediately to begin the process of representation assistance.

Over the last five years, TSACG has served as Special Power of Attorney for 35 public education employers for the duration of the IRS audits of their retirement plans.

As the administrator and per the terms in our contract, we fully assist in the event of audit. We ask the plan sponsor to execute an IRS form 2848, which provides a limited power of attorney while under audit.



Our audit team assembles all requested materials and obtains all needed information from the investment providers. Our team also works with the plan sponsor to obtain any information that is housed only at the employer level. We then assimilate all information so that the auditor has easy access to the material requested.

A program consultant is in attendance for the first meeting with the auditor and follows the audit through until the closing letter is received from the IRS.

When processing 403(b) and/or 457(b) plan contributions, it is important to remember that time is of the essence. Department of Labor rules require that Plan Sponsors remit 403(b)/457(b) deferrals to the plan's authorized investment providers as soon as possible; however, in no event can the deposit be later than the 15th business day of the month following the month in which those amounts would have been payable to the participant.

With this in mind, TSACG recommends that all Plan Sponsors remit 403(b)/457(b) contributions as soon as administratively feasible, and preferably every payroll. "Rolling-up" plan remittances into a single deposit each month can greatly increase the risk of violating the timely deposit rule and a plan failure.
